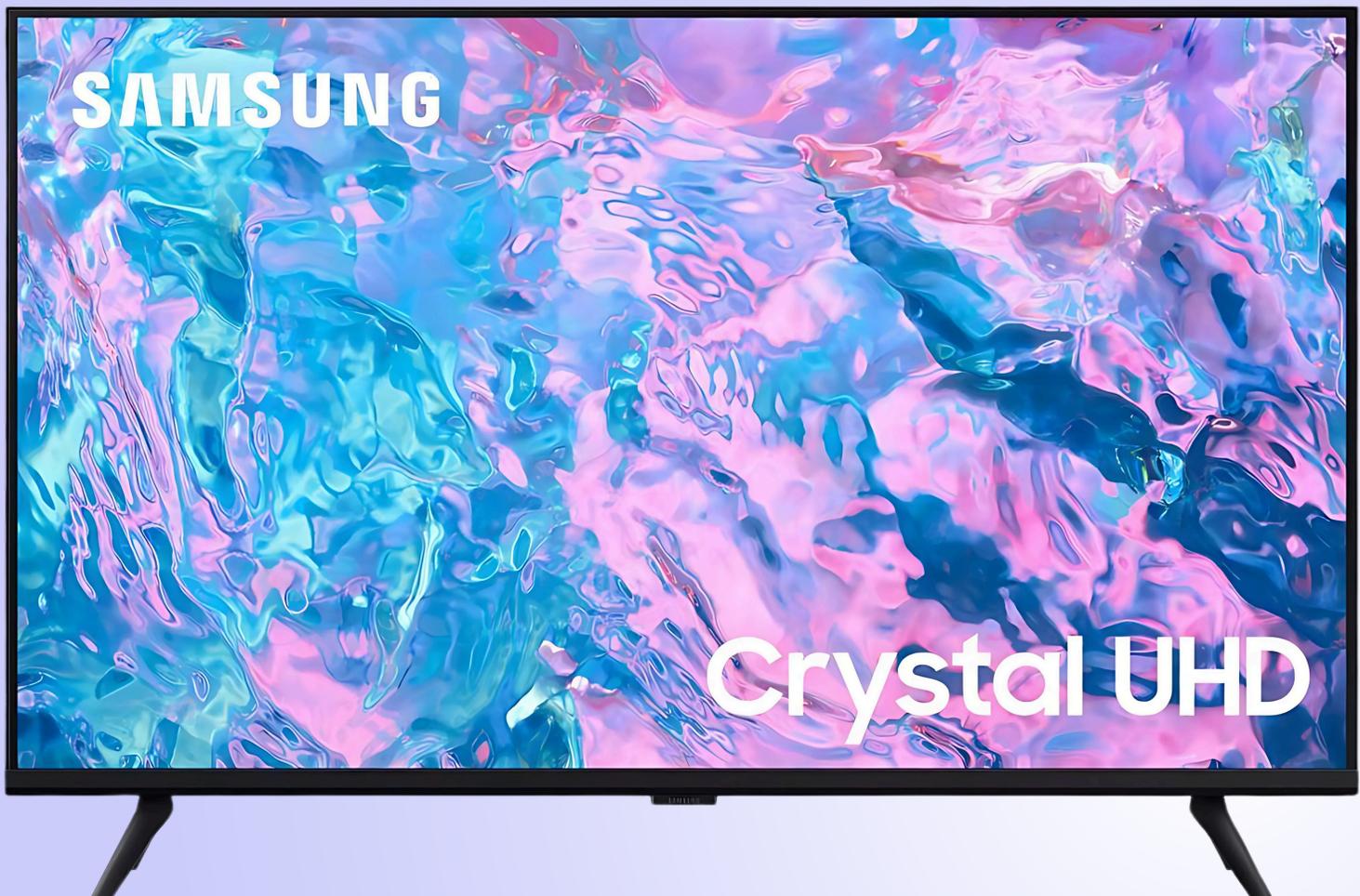

	A staff member gives up some of their salary before tax each month.
	In return, they can obtain a selection of the latest home electronics.
	The employee chooses to spread the cost over 12 or 24 months.
	Once all sacrifices have been made the employee's salary will return to normal.

Local rules can be set to allow restrictions on spending and minimise administration. Full support is provided to help shape a policy and marketing strategy which suits the goals of your organisation.
